## Special Town Meeting

To either of the Constables of the Town of Ashfield in County of Franklin,  
GREETINGS. In the name of The Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at the ASHFIELD TOWN HALL in said Ashfield on **WEDNESDAY, the THIRTEENTH OF MARCH, 2013** at SEVEN O'CLOCK in the evening, then and there to act on the following articles:

**ARTICLE 1.** To see if the Town will vote to transfer up to \$5,000 from Free Cash to Legal Expense, or act relative thereto.

**ARTICLE 2.** To see if the Town will vote to transfer up to \$7,000 from Free Cash to an account to be established as Special Legal Expense, or act relative thereto.

**ARTICLE 3.** To see if the Town will vote to transfer up to \$3,000 from Free Cash to Special Project Staffing Fund, or act relative thereto.

**ARTICLE 4.** To see if the Town will vote to transfer up to \$1,000 from Building Inspection to Elections Expense, or act relative thereto.



**ARTICLE 5.** To see if the Town will vote to transfer up to \$3,300 from Building Inspection to Fire Department Grant Match for the purpose of accepting a Fire Department Forestry Matching Grant, or act relative thereto.

**ARTICLE 6.** To see if the Town will vote to transfer up to \$4,500 from Building Inspection to Tree Warden Expenses, or act relative thereto.

**ARTICLE 7.** To see if the Town will vote to transfer up to \$6,700 from available funds as follows: \$1,791 from Police Vehicle FY12, \$909 from Police Department Fuel, \$4,000 from Tax Title Expenses to Police Department Expense, or act relative thereto.

And you are directed to serve this Warrant, by posting up attested copies thereof at the ASHFIELD TOWN HALL and the ASHFIELD POST OFFICE in said Town, FOURTEEN days at least before the time of holding said meeting. Hereof Fail Not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting, as aforesaid.
