

On May 2, 2009, an Annual Town Meeting was called to order at 10:01 am in the Town Hall. Moderator Buz Eisenberg presided. Check in person was Renee Rastorfer. Tellers were Lynn Dole, Sarah Holbrook, Betty Stewart and Emma Svoboda.

The following is a true copy of the votes taken:

ARTICLE 1: Motion was made, and seconded, that the Town open the polls to choose a MODERATOR and a TREE WARDEN, both for one year terms. A SELECT BOARD MEMBER, BOARD OF ASSESSORS MEMBER, SCHOOL COMMITTEE MEMBER, BOARD OF HEALTH MEMBER, CONSTABLE, PARK COMMISSIONER, , and A SEWER COMMISSIONER all for three year terms; A LIBRARY TRUSTEE and a PLANNING BOARD MEMBER, both for five years; A BOARD OF HEALTH MEMBER for an unexpired term. To vote on the following question:

“Shall the town of Ashfield cease assessing the excise imposed under General Laws Chapter 59, Section 81 on certain animals, machinery and equipment owned by individuals and non-corporate entities principally engaged in agriculture?”

Polls to be closed at 6:00 PM.

Article passed unanimously.

ARTICLE 2: Motion was made, and seconded, that the Town accept the reports of the Town Officers.

Article passed unanimously.

ARTICLE 3: Motion was made, and seconded, that the Town set the salary compensation for all elected officials of the town (Select Board, Board of Assessors, Board of Health, Moderator, Tree Warden and Constable) as provided by MGL Chapter 41, Section 108, to be made effective from July 1, 2009, as contained in the budget.

Finance committee unanimously recommended this article.

Article passed unanimously.

ARTICLE 4: Motion was made, and seconded, that the Town raise and appropriate the following sums of money to pay for **VOCATIONAL SCHOOL EXPENSES AND EDUCATIONAL CAPITAL EXPENSES.**

Finance committee unanimously recommended this article.

Article passed by a majority.

ARTICLE 5: Motion was made, and seconded, that the Town raise and appropriate \$1,594,679 and transfer from free cash \$250,000 for a total of \$1,844,679 to pay for **REGIONAL EDUCATIONAL EXPENSES**.

Finance committee unanimously recommended this article.

Article passed by a majority.

ARTICLE 6: Motion was made, and seconded, that the Town accept the amended Mohawk Trail Regional Agreement as posted at the Ashfield Town Hall and the Ashfield Post Office.

Finance committee unanimously did not recommend this article.

After discussion, motion was made, and seconded, to call the question. The motion passed by the required two-thirds.

Article passed by a majority.

ARTICLE 7: Motion was made, and seconded, that the Town raise and appropriate the following sums of money to pay for **AMBULANCE SERVICE**.

ARTICLE 8: Motion was made, and seconded, that the Town raise and appropriate \$4,500 to pay for the **RESERVE ACCOUNT**.

Article passed unanimously.

ARTICLE 9: Motion was made, and seconded, that the Town raise and appropriate \$193,033 and transfer from \$20,300 from excess overlay, \$2500 from Grant Program Income and \$2000 from the Fred Cross Fund for a total of \$217,833 to pay for **GENERAL GOVERNMENT EXPENSES**.

Article, as originally moved, passed unanimously.

ARTICLE 11: Motion was made, and seconded, that the Town raise and appropriate \$179,820 and transfer \$2279 from the Revolving Dog Fund for a total of \$182,099 to pay for **PUBLIC SAFETY** expenses.

ARTICLE 12: Motion was made, and seconded, that the Town authorize the Select Board to appoint Bill Perlman to serve as Emergency Management Director, and to supervise him in that position, while he continues to serve as a select board member.

Finance Committee had no recommendation.

Article passed unanimously.

Motion was made, and seconded, to amend the article to increase the Belding Memorial Library by \$1678.

Because this motion exceeded the post warrant by 5%, the moderator asked for a motion which was then seconded, to allow an amendment to exceed the warrant by 5%. The motion passed by a majority. (30 yes; 22 no)

Motion was then made, and seconded, to amend the amendment to state that the money would come from free cash.

After discussion, motion was made, and seconded, to call the question. Motion passed by the required two-thirds.

Motion to amend the amendment failed by a majority.

After discussion on the original amendment, motion was made, and seconded, to call the question. Motion passed by the required two-thirds.

Motion to amend the article failed by a majority. (30 yes; 32 no)

Article as originally moved passed by a majority.

ARTICLE 26: Motion was made, and seconded, that the Town repeal and replace Article 5c, Section 1.2 and 1.3 of the Dog Bylaw to read as follows: Section 1.2 The fees shall be as prescribed in MGL chapter 140, except that the annual fee for the licenses shall be set by the Select Board, pursuant to section 1.4 of the bylaw and Section 1.3 An additional late fee shall be set by the Select Board, pursuant to section 1.4 of the bylaw, shall be assessed to a dog owner who fails to properly license his dog by the last day that town hall is open for business in April of any year.

ARTICLE 27: Motion was made, and seconded, that the Town authorize the Select Board to accept and expend any grants and/or gifts that may become available.

Article passed unanimously.

ARTICLE 28: Motion was made, and seconded, that the Town authorize the Select Board to dispose of any unused town-owned equipment and/or property.
