In the name of The Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said Town, qualified to vote in elections and in Town affairs, to meet at SANDERSON ACADEMY in said Ashfield on Wednesday, **the thirtieth of June, 2010** next, at **SEVEN O'CLOCK** in the evening, then and there to act on the following articles:

ARTICLE 1: To see if the Town will vote to appropriate and/or transfer from available funds the amount of \$31,700 to pay for Ice Storm expenses, or act relative thereto.

ARTICLE 2: To see if the Town will vote to rescind the Annual Town Meeting vote of May 1, 2010, which was amended to say:

“...that the town raise and appropriate \$405,454 to pay for the following **HIGHWAY AND ROAD EXPENSES:**

“...that the town raise and appropriate \$35,275 and transfer \$6000 from Free Cash for a total of \$41,275 to pay the following sums of money for **CULTURAL/RECREATIONAL EXPENSES**:

ARTICLE 4: To see if the Town will vote to appropriate and/or transfer from available funds the amount of \$74 to pay for Local Council on Aging expenses, or act relative thereto.

And you are directed to serve this Warrant, by posting up attested copies thereof at the ASHFIELD TOWN HALL and the ASHFIELD POST OFFICE in said Town, FOURTEEN days at least before the time of holding said meeting. Hereof Fail Not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting, as aforesaid.
